The Department of Medical Assistance Services (DMAS) is conducting several provider training sessions on the Addiction and Recovery Treatment Services (ARTS) implementation effective April 1, 2017. These sessions will review the new ARTS Provider Manual including provider requirements, covered services, documentation and billing requirements and the ARTS reimbursement structure.


DMAS will have Medicaid Managed Care Organization (MCO) and Magellan staff representation at these sessions to answer questions on the ARTS contracting and credentialing process, billing processes, etc.

Online Training Registration

The training sessions will be **on-site at the locations identified in the letter, NOT ONLINE.**

We will be using Adobe Connect for the on-site registration process only. Online Medicaid training registration can be accessed at <http://dmasva.dmas.virginia.gov/>. On the left hand menu click the Learning Network link then click the Current and Upcoming Training Events link. Open the **ARTS Provider Manual Training** letter, scroll to the third page and select the link given that corresponds with the session you wish to attend. The links will open the Adobe Connect registration page to the training scheduled for that day and time. Each participant's name and valid email address will be required for registration. Once registration is approved, you will receive a confirmation email with all of the training details. The number of participants allowed in each session is limited. VA BEACH – VIRGINIA BEACH CENTRAL LIBRARY- AUDITORIUM

(The entrance to the auditorium is on the right side of the Library). **From I - 264 East-** Take Independence Blvd. (towards Pembroke). Turn right onto Virginia Beach Blvd. (U.S. 58). The library will be on the left. There will be a Central Library sign.

VARINA – VARINA LIBRARY

Directions from North take I-95 North; Take ramp toward Richmond, Take ramp and follow signs for VA-895 West, Turn left onto S Laburnum Avenue, Arrive at VA-5/New Market Road toward Allegro Drive

Directions from South; Take ramp right for I-64 West toward Richmond (Seven Pines/Bottoms Br) At exit 25 take ramp right for VA-895 West Toward Richmond, Take ramp right for Laburnum Ave towards New Market Road. Turn right onto VA-5/New Market Rd, Arrive at VA-5/New Market Rd arrive at 1875 New Market Rd, Henrico, VA 23231

CHARLOTTESVILLE – CENTRAL LIBRARY

Follow **I-64 W** to US250 exit, Exit 124, Turn R on Richmond Rd/US 250W, Continue to follow US 250 Bus W/VA-20, Turn R onto E Market Street/US-250 Bus W/VA-20, Turn R onto E Market St/US-250 W. Library on the Right

PRINCE WILLIAM – A.J. FERLAZZO BUILDING

(The Ferlazzo Building is a two story brick building on the right side of the road. Auditorium is on ground floor.)

FROM I-95: Take **Exit 152A**, Hwy. 234S toward Dumfries. Turn Left at US-1. Turn left onto Cardinal Drive, make a left at Carroll Avenue and continue on to Donald Curtis Drive, building will be on your left.

FROM I-66: Take the Prince William Parkway/Route 234 By-Pass **Exit #44** and continue south on the Prince William Parkway/Route 234 By-Pass to the intersection with Dumfries Road/Route 234. Go straight through the intersection to continue south on Dumfries Road/Route 234. Travel approximately 15 miles to Jefferson Davis Highway/Route 1. Turn left on Jefferson Davis Highway/Route 1 and travel north to Cardinal Drive. Turn left on Cardinal Drive. Turn left on Donald Curtis Drive at the first traffic light.

WINCHESTER-LORD FAIRFAX COMMUNITY COLLEGE – MC COY THEATRE

From the north: I-81 South to Exit 302 (Reliance Road), Turn right at stop sign, travel 0.3 mile to Route 11. Turn right at stop sign. LFCC is 0.1 mile on right. **From the south:** I-81 North to Exit 302 (Reliance Road), turn left at stop sign, travel 0.5 mile to Route 11. Turn right at stop sign. LFCC is 0.1 mile on right. **From the east:** I-66 West to I-81 North to Exit 302 (Reliance Road), turn left at stop sign, travel 0.5 mile to Route 11. Turn right at stop sign. LFCC is 0.1 mile on right. **From the west:** I-81 North and follow the directions coming from the south

LEBANON – RUSSELL COUNTY GOVERNMENT CENTER

I-81 S At exit **17** take ramp right for **US-58-ALT/VA-75** toward **South Holston Dam/Abingdon**, Turn **right** onto **US-58 ALT/VA-75/Cummings St SW**, Turn **left** Turn right onto **US-58 ALT/ US-11**, Turn right onto Road name changes to **US-58 N ALT/US-19 N**, Keep **straight** onto **US-58 W Alt/US-19N**, At exit **2**, take ramp **right** toward **Lebanon**, Turn **left** onto **Pittson Rd**, Turn **left** onto **US-19 BR/E Main St**, Arrive at **US-19 BR/E Main St, Government Center Drive, Lebanon, VA 24266**

ROANOKE – VIRGINIA WESTERN COMMUNITY COLLEGE- WHITMAN THEATRE

(Whitman Theatre is in the Business Science Building, across the street from the parking lot 7)

From Interstate 81: Take I-581/220 South to Colonial Avenue Exit ~ 8 Miles .Take a left at the stoplight at the end of the exit ramp. At the 3rd light the VWCC Campus is located on both sides of Colonial Ave. From 220 South: Take Colonial Ave /Wonju Exit off 220/I-581. Turn right at end of ramp and continue to stoplight. Turn left at light onto Colonial Avenue. Continue on Colonial Avenue through next light. VWCC is located on both sides of Colonial Ave. Parking is restricted. Please park in Lot 7 or 9.

Newport News Main Street Library From 64E toward Norfolk, At exit 258A, take ramp right and follow signs for US-17 South 1.7 miles, Turn left to stay on US-17 S/ VA – 143 E / Jefferson Avenue Pass Exxon on the left in 1.1 mi, Go 2.9 miles then turn right onto VA-152/Main Street, Go 0.4 miles arrive at 110 Main Street, Newport News, VA 23601
